The following are dispositions of disciplinary hearings held by the Deputy Chief of Homeland Special Operations on Tuesday, February 12, 2014.

Detective Thomas Lett #259 - Improper Procedure - Unauthorized Secondary Employment - Improper Conduct - Insubordination - AWOL - Failed to appear for disciplinary hearing. Detective Thomas Lett #259 received a six (6) day (forty-eight [48] hour) suspension without pay with three (3) of the days (twenty-four [24] hours) held in abeyance until February 12, 2016.

Patrol Officer Christopher Allen #149 - Improper Procedure - Engaged in vehicle pursuit without permission. Patrol Officer Christopher Allen #149 received a "Written Warning."

Patrol Officer Carma Crosby #1512 - Improper Procedure - Failed to properly book OVI arrest - Improper court date - Failed to complete BMV Forms - Failed to appear in court. The charge of failing to appear in court was dismissed. However, Patrol Officer Carma Crosby #1512 received a "Written Warning" on the remaining charges. In addition, she is required to attend remedial O.V.I. retraining prior to December 31, 2014.

Patrol Officer Rico Levert #2255 - Improper Procedure - Failed to properly book OVI arrest - Improper court date - Failed to complete BMV Forms - Failed to appear in court. Patrol Officer Rico Levert #2255 received a "Written Warning." In addition, he is required to attend remedial O.V.I. retraining prior to December 31, 2014.

Patrol Officer Donald Kopchak #2139 - Improper Procedure - Completed erroneous Daily Duty Report. The disciplinary action was "Dismissed." However, Patrol Officer Donald Kopchak #2139 received a "Non-Disciplinary, Corrective Letter of Re-Instruction."

Patrol Officer Robert Nagy #1909 - Improper Procedure - Sick Leave Abuse. Patrol Officer Robert Nagy #1909 was placed on "Step-1 of the Sick Leave Abuse Control Program" until February 12, 2015.

Patrol Officer Brendan Russell #155 - Improper Procedure - Use of sick leave to avoid difficult or undesirable duty - The charges were "Dismissed."
